COVID-19 heavily hit the development of any activity in 2020. Hopefully, culture Solutions was created as an online organisation. In a way, cS was ready for lockdowns.

The pandemic has brought us all some opportunities, whether we are jobless, alone, keen to learn or eager to publish and meet new people (online!).

At the same time, along the year we have been caught in the pandemic's inertia: no geographical mobility, no face-to-face meetings, no networking opportunities, close to no fundraising. Yet, cS showed resilience.

2020 was the year of growth, with the launch of the first annual research report, Composing Trust 2019/20. It attracted the attention of EU institutions with which we closely collaborated on their new policy priority: protection of cultural heritage in conflict.

The organisation attracted new pro bono collaborators and started its consolidation, aware of the limitations of its pro bono business model



2020 was a groundbreaking year with the publication of the first cS Research Report, Composing Trust 2019/20, made up of 9 briefs, despite the publication being delayed by COVID-19 and the dissemination hampered by the lockdown. We also published our first cS country mapping on classical music in China in partnership with a locally-based organisation.


